Highlights of Vestry Meeting - December 11, 2018

Opening & Formation

The meeting opened at 7:03 p.m. with prayer led by Fr. Douglas. A quorum was present. A brief time of formation and discussion followed.

DISCUSSION & DECISION

Structure - Commissioned Vestry

Fr. Bob encouraged anyone who has not yet done so, to meet with him to discuss their commission structure. He also shared a document of ideas for possible taglines, and invited vestry members to work on creating others for a cohesive brand identity for St. Mark's. Those he created use the key words that were brought up at last month's meeting. These were reviewed and discussed, with a couple of straw votes taken for favorites. Further discussion and decision was tabled until the January meeting.

Stewardship Update

Bill Lynch reviewed information about our pledge drive for 2019 compared to 2018. There are over 20 people who pledged in 2018 but not for 2019. This group will receive a letter from the rector. There are some new pledgers, and everyone who has pledged will receive a simple thank you letter. We have some way to go to close the revenue gap for the 2019 budget. It seems like people have done a good job catching up their pledges. Earlier in the year we were further behind than we are now. The average amount of 2019 pledges is \$200 lower than the average for 2018.

New Members Update

We are renewing the process of greeting and capturing information from visitors. This will include temporary name tags that Fr. Bob can easily identify. The welcome packets have been updated and Elaine Douglas will chair this project and join the greeter team. One challenge is to greet visitors as they exit the sanctuary and invite them to coffee hour. Vestry can help with this, as Fr. Bob is often held up talking to people after church. As leaders, vestry members are the best people to help with this. There will be a Newcomer Dinner on February 19th.

Communications Update

Communications was busy in the past month working on ways to promote our December events with more intention. This includes a paid Facebook ad which has reached a larger number of people than other methods and directs people to our website. Diann Crawford advised that if groups have events, they can contact her to get write ups done, or have photos taken to get activities promoted.

Safety Committee Update

Fran Weissing has put together a simplified final report of the committee. They hope to train ushers in January about emergency procedures. Other projects such as lighting and door repairs will be done as budget allows.

Buildings & Grounds/Lighting at Night

Outside lighting is sporadic and inadequate. The timers are not working properly. An electrician recommended using a simple pool timer for the lights mounted in the trees. Nobody has been able to figure out how to control the overhang lights. The junior warden is talking to the Garden Club about placing some solar pathway lights.

COMMISSION REPORTS REVIEW

Fr. Bob asked for reports to be submitted before the meeting. A couple of items were not covered in reports: there is a plan forming to refresh the Atrium and Narthex; Fran Weissing sent a Christmas and birthday gift package to our sponsored child at Our Little Roses.

TREASURER'S REPORT

Fr. Bob reviewed the Treasurer's report. November did not end well, but the first two weeks in December have been better. Cash is still tight and expenses being contained. We have paid recent apportionments late, but they have been sent. If December remains good, we will finish the year caught up.

Approval of Financial Reports

Diann Crawford moved to accept the November financial reports. The motion was seconded by Fran Weissing and carried unanimously.

Conclusion

The discussion was opened to reflections and final comments.

Laura Jeanne Johnson moved to adjourn the meeting. Sam Trotman seconded and the meeting was unanimously adjourned at 8:38 p.m.
